

**Minutes of the Meeting**








The Departmental meeting was held on 10th July 2019 at 12:30 pm. Following matters were discussed in the meeting:






**Highlights-**

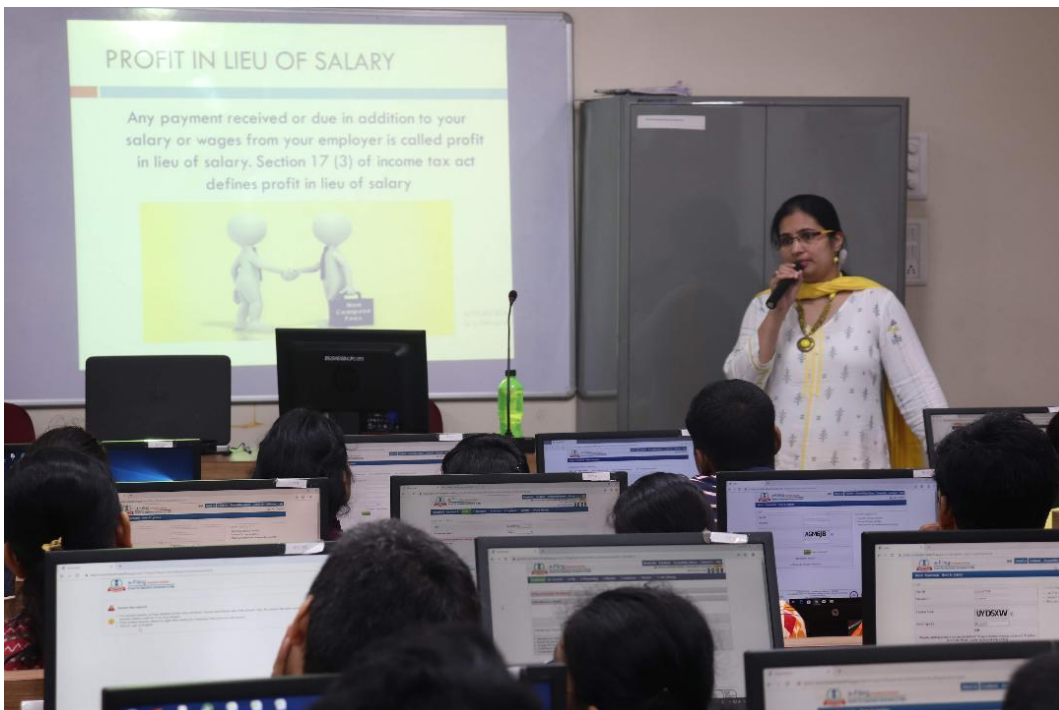

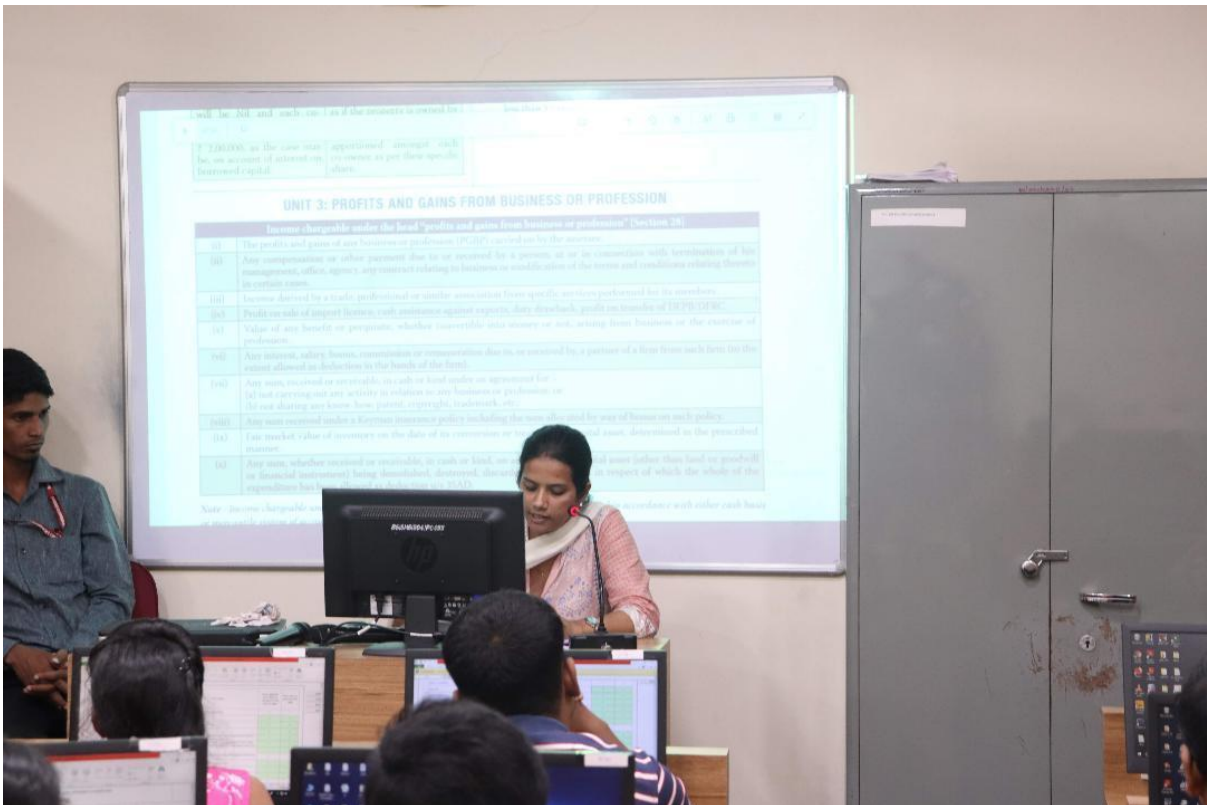


