
Subject : Permission to visit Bombay High Court

Apropos the subject mentioned above and the letter under reference, I inform you that permission has been granted for 60 students including faculty members to visit the Bombay High Court on Thursday, 16th March 2023 during office hours (from 10.30 a.m. to 1.30 p.m. or 2.30 p.m. to 4.30 p.m.) alongwith an Officer of this Court (viz. Court Keeper – 22673466) only for observing the procedure and actual working of the Judicial system of the High Court as part of their academic syllabus on following conditions :-

- (a) That while visiting the High Court premises and the Court Rooms, they must move around in small groups (10 students per group) without carrying any bag / sack in Court Rooms;
- (b) That no disturbance whatsoever should be caused in the Court Rooms and in the precincts of the Court;
- (c) That the Mobile phones should be either muted or switched off.
- (d) That the conduct or behaviour of students should not cause annoyance or embarrassment to anyone inside the premises.
- (e) That no photographs/shooting of interior of the Court Rooms and / or High Court Buildings should be taken.
- (f) They should maintain Social Distancing and follow all the Covid-19 Rules / Norms/ Guidelines issued by the Government of Maharashtra.
- (g) That they should be fully vaccinated and should carry their **Final Certificate for COVID-19 vaccination.**
- (h) That no damage should be caused to the High Court Building and / or its precincts during the said visit.

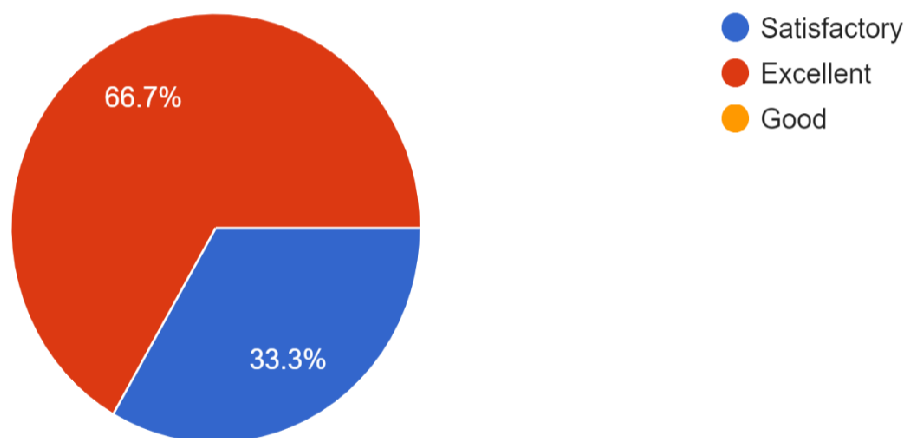

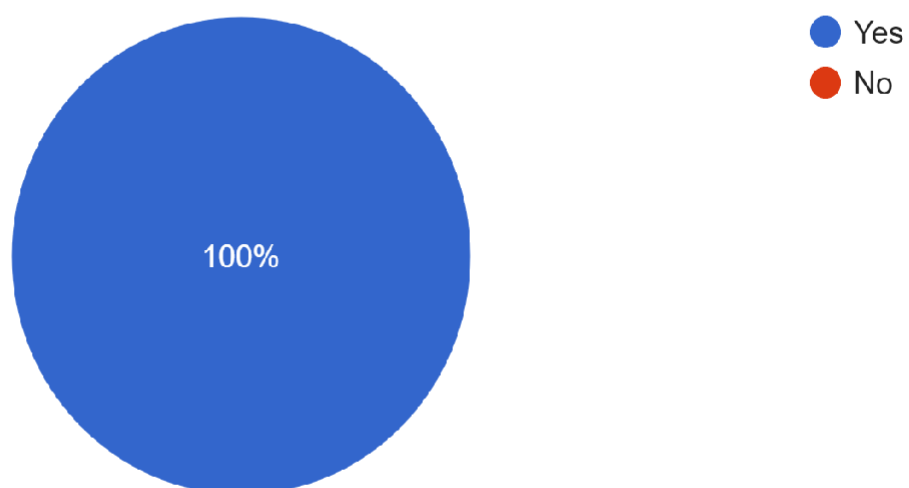
HOW WAS THE VISIT EXPERIENCE TO THE HIGH COURT?
